**GUIDELINES FOR A SAFE, FUN, AND MEMORABLE BOATING ADVENTURE!**

**TIME OF DELIVERY:**

- Please have driver's license ready and your credit card or cash for your damage deposit.
- Adult Life jackets will be provided for each of the 7 riders. Try them on to ensure a proper fit.
- Complete, sign, and return the rental agreement.

**BEFORE DEPARTURE:**

- Inspect the watercraft, you are responsible for any damage incurred while renting the watercraft.
- Verify that you have a copy of the rental contract and liability waiver.
- Verify that you have enough gas in the watercraft to make it to your next stop. If the craft requires fuel please inform administration for refueling purposes.

**UPON RETURNING:**

- Return all items used for the trip. This includes the watercraft, life jackets, key and lanyard, any and all safety equipment. You are responsible for any lost items and will be charged accordingly.
- Report any problems encountered or damage that occurred while the watercraft was in your possession.

## ON THE WATER!

- The motor must not be started or running in less than 2 feet of water.
- Pay attention to all traffic on the water. As this watercraft is most maneuverable on the water, it will be your responsibility to yield the right of way to all other watercraft.
- Watercraft should not be running if there is anyone in the water in the immediate vicinity! Severe injury can occur in a very short time.
- Generally, the "rules of the road" on the water is similar to those on land. Oncoming traffic should be passed on the right, do not cut across another boats bow. When passing traffic going in the same direction, pass to the left, leaving as much space as possible between watercraft. A safe rule of thumb is 200 feet between watercraft.
- When leaving the watercraft unattended (beaching the watercraft at your favorite sandbar, for example), remove the key and lanyard from the watercraft and keep it with you. You will be responsible for lost or stolen watercraft while in your possession.

### Operating Policies & Agreement

- Candle Lake Golf Resort, may refuse, at its sole discretion, to rent to persons it feels are not qualified to operate the craft safely.
- Renter must be a responsible adult at least 21 or over with a valid driver's license.
- The craft will be assigned to the renter and a rental agreement must be completed before departing the launch site.
- Candle Lake Golf Resort, may terminate, without refund, the rental of the craft, if in its sole judgment, the craft is operated unsafely or the renter violates any of the terms of the rental agreement or rental policies.
- The person providing the deposit must be the one to sign the Boat Rental Agreement.
- The rented craft shall not be used for any unlawful purpose or operated under the influence of alcohol or drugs.
- Watercraft occupancy must not exceed boat capacity of 7 People.
- No nighttime running- craft must be secured between sunset and sunrise.
- Any person not signatory to the Rental Agreement may not operate the craft.
- Absolutely no pets allowed.
- Renter is responsible for learning and obeying all local, provincial and federal laws pertaining to operating the rented craft.

### DISCLAIMER CLAUSE:

1. (a) The renter of this watercraft hereby acknowledges that he/she is aware of the inherent risks involved in the use of the watercraft and, in consideration for the vendor renting to the purchaser the within watercraft, the renter hereby agrees to assume all risk of personal injury, death, or the inherent risks and dangers associated with the said snowmobile.  
(b) The renter herein further expressly agrees that the Vendor and /or its employees and agents shall not be liable for any such personal injury, death or property loss and hereby releases the Vendor and its employees and /or agents and waives all claims with respect thereto.
